### Course Description

This course explores how the structural, competitive, economic, environmental and ethical forces affect the continuing transformation of the communications industry both domestically and internationally. Discussion of the impact of contemporary issues on the provider and the consumer of communications services including the legal and ethical requirements and ramifications of electronic privacy.

This is an "online" class, which means that you will consume the course content via prerecorded videos and perform assignments and exams as directed in the course modules. We will not meet together on a regular basis.

- An ability to make informed judgments in computing practice based upon legal and ethical

principles.

# COURSE POLICIES

## Academic Honesty/Ethical Conduct
